### NOTICE NO. 006/2023 – SELECTION AND ACCREDITATION OF PROFESSIONALS FOR DEVELOPING PROJECTS RELATED TO CARBON CREDIT GENERATION AND/OR PROJECTS FOR MEASURING AND INVENTORY OF GREENHOUSE GAS EMISSIONS – GHG, WITHIN THE TRIPLE C PROTOCOL STANDARD, by LUXCS.

#### ABOUT THE OBJECTIVE

LuxCS, Lux Carbon Standard Ltda. – LuxCS (Translator's notes: limited company), CNPJ No. 48.846.500/0001-75 (TN: tax identification number of a company in Brazil), a Carbon Credit Certification Company, operating under Brazilian laws, hereby informs interested parties that registration is open for project developers for the generation of carbon credits in the voluntary market, validated, verified, and registered within the parameters of the **Triple C Protocol** standard, or for developers of projects for measuring and inventory of greenhouse gas emissions – GHG, within the parameters of the **Triple C Protocol** standard – **UnCarbonize** program.

#### ABOUT ELIGIBLE CANDIDATES

To participate in this selection and accreditation process, interested professionals must meet the following requirements and register on the LuxCS Platform (<https://plataforma.luxcs.org/#/login>) the following **documents** in PDF format:

- a. Be accredited in the respective Professional Council. For verification, supply a valid professional ID, updated certificate from the professional council with the registration status and other information about the activity with the entity, updated certificate from the professional council of regularity with the entity.
- b. If the professional provides services through a Legal Entity, this company must be up to date with all taxes and registrations in Professional Councils. For verification, supply an updated certificate from the professional council with the registration status of the legal entity and other information about the activity with the entity, updated certificate from the professional council of regularity of the legal entity with the entity, negative certificates of debt of federal, state, and municipal taxes.

### **ABOUT THE SELECTION**

The selection of the accredited will be made through: (a) analysis of the documentation sent at the time of registration on the LuxCS platform (<https://plataforma.luxcs.org/#/login>), and (b) conducting a proficiency examination to assess the technical capacity of the examinees in topics related to the process of carbon credit generation.

### **ABOUT THE PROFICIENCY EXAM**

The proficiency exam will consist of 25 (twenty-five) multiple-choice questions. The exam will have 5 (five) questions on each of the following topics:

- a) The carbon credit markets, regulated and voluntary.
- b) The Triple C Protocol standard (Carbon Compensation Credit) of LuxCS. The codes of conduct of LuxCS and the ICROA (International Carbon Reduction & Offset Accreditation).
- c) The LuxCS Platform and its use. The Platform follows and monitors the processes of Methodology Validation by third-party audit, Project Development by accredited professionals, Verification by third-party audit, and Registration of generated carbon credits.
- d) The UnCarbonize Program which encourages the measurement, estimation, and partial or total compensation with carbon credits of organizations and production chains.

LuxCS will send, to the email registered by the interested party, material for studying the required themes in the Proficiency Exam. In this communication, information will also be provided to the candidate on how to take the Proficiency Exam.

## APPROVAL AND ACCREDITATION

A candidate will be considered approved if they correctly answer 18 (eighteen) out of the 25 (twenty-five) questions in the Proficiency Exam and, at least, 3 (three) questions in each of the thematic areas.

The approved candidates will be accredited to the LuxCS Platform as project developers and will need to validate this status annually. For this purpose, there will be specific communication to each registrant, in a notice specifically for this purpose.

## FINAL PROVISIONS

The candidate, by accepting the conditions established in this Notice, is responsible for all the information contained in their registration, allowing LuxCS, at any time, to confirm the veracity of the information provided.

All information received from candidates will be treated as confidential.

Candidates may be selected whose project development is conditioned on the emergence of demand from a property owner or area responsible or that this demand is in the process of documentation evaluation by the Certifier LuxCS.

There will be no employment relationship, under any circumstances, between LuxCS and the selected project developers, their employees or agents, who are considered project developers and who will issue invoices for their services at the end of them, against the area owner or their legal representative, in the case of projects for the generation of carbon credits in the voluntary market, validated, verified, and registered within the parameters of the **Triple C Protocol** standard.

There will also be no employment relationship, under any circumstances, between LuxCS and the selected project developers, their employees, or agents, who are considered project developers and who will issue invoices for their services at the end of them, against the contracting legal entity, in the projects of measurement and inventory of greenhouse gas emissions – GHG, within the parameters of the **Triple C Protocol** standard – **UnCarbonize** program.

LuxCS, as a Certifier, will act in these projects only as a supervisor and stimulator of the same and with the purpose of encouraging the improvement of the **Triple C Protocol** standard and the voluntary carbon market.

Omissions in this Notice will be resolved by the Chief Governance Officer, CGO, of LuxCS, Adv. Thiago Pamplona da Silva Müller, OAB No. 25.887 (TN: Bar/Lawyers Association number by state in Brazil).
